Verification by a committee towards the fulfillment of the conditions mentioned above and the continued fulfillment of the requirements for the above-mentioned course(s) as per the norms and standards of AICTE and the laboratory requirements as per the curricula and syllabi of Anna University for the above courses. In the event of any violation/infringement of the above said conditions and /or the provisions of Anna University Act/ Statutes / Regulations, AICTE Act, norms & standards / regulations / guidelines or any other law time being in force, suitable action including suspension/withdrawal of affiliation of course(s) may be initiated against the college.

The provisional affiliation is granted without prejudice to the right of the University of requiring production of certificate required under Section 37-B of Tamil Nadu Land Reforms (LC) Act 1961 subject to the decision of the Hon 'ble High Court of Madras in W.A.No. 3454 / 2002 batch and W.A.No. 3482 / 2002 batch.

Under no circumstance fresh admission be made in the above course(s) during the academic year 2006-07, until and unless the continuation of provisional affiliation is obtained from the University.

The Management should submit a duly signed undertaking on a Rs. 20/- non-judicial stamp paper to the Registrar, Anna University, Chennai – 600 025, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled and should submit a compliance report to the University within 60 days from the date of receipt of this letter.
